## CITY OF MANZANITA PLANNING COMMISSION MEETING MINUTES JANUARY 21, 2020

- **I. CALL MEETING TO ORDER**: Chair Karen Reddick-Yurka called the meeting to order at 4:01 p.m.

## V. DISCUSSION ON ACCESSORY DWELLING UNITS

City Manager Alamillo explained to the Commission that they would be reviewing the 2019 Department of Land Conservation and Development's Guidance on Implementing the Accessory Dwelling Units (ADU) Requirement handout a few sections at a time to gain a full understanding before addressing changes to City code. The topics discussed were: the number of ADUs required to be allowed per detached single-family dwelling; siting standards such as where to allow ADUs, non-conforming structures, and parking concerns; design standards including setbacks, open space, maximum height, and ADU size restrictions; and what the City would allow ADUs to be used for.

City Manager Alamillo will provide to the Commissioners for review copies of or email links to zoning ordinances from cities that have finished the process of incorporating ADU language into their code. The Commissioners will provide Alamillo written comments and questions to be forwarded to the DLCD. Alamillo stated that this discussion of ADUs will continue at the regular February 2020 Planning Commission meeting.

## VI. GENERAL UPDATES

City Manager Alamillo informed the Commission that they would be considering a design Planning Commission

review application from the owners of the Manzanita Deli at their regular March 2020 meeting. Alamillo also stated that she is working on scheduling a joint meeting of the Planning Commission and the City Council within the next month to discuss Council Goals; noted the Planning Commission Handbook that had been provided to them; and explained that Jim Pentz is still working on his final plat.

A motion was made by Nanson, seconded by Went, to adjourn the meeting. Motion passed unanimously.
