Please Continue to Wear a Face Mask in Public

Manzanita is a small town with small spaces, made even smaller during busy weekends and holidays. Center for Disease Control (CDC) continues to study the spread and effects of COVID-19 across the United States.

Studies show that the virus can spread between people interacting in close proximity—for example, speaking, coughing, or sneezing—even if those people are not exhibiting symptoms.

In light of this evidence, CDC recommends wearing cloth face coverings in public settings where other social distancing measures are difficult to maintain (e.g., grocery stores and pharmacies) especially in areas of significant community-based transmission. The majority of our merchants require the wearing of a face mask to enter their businesses and will do so for the foreseeable future. Share the love, wear a mask!
