# **SUMMARY**

This report describes the efforts of the Manzanita Listens research team to help the City of Manzanita assess the public's opinions about building a new city hall. The research team sought to collect a broad range of views from Manzanita homeowners, renters, non-resident property and business owners, as well as local residents who live outside the city limits.

The report presents results from two separate research efforts: a broad survey and a series of three focus groups. The results of the survey were used to develop questions for deeper exploration through the focus groups. Results from the focus groups were further used to develop topics for larger public meetings, which were conducted by a different team of researchers.

**Note.** Public meeting results are covered in a separate report.

#### **KEY SURVEY FINDINGS**

Key findings from the survey:

Local voters interacted with services more than non-resident property owners.

Respondents clearly indicated that cost was the most important aspect for the city to consider.

Respondents ranked emergency services as the second most important aspect, but other building aspects were ranked highly as well.

Local voters favored financing through charges on short-term rentals, but they were open to other financing mechanisms.

Open comments suggested other features and uses for city hall.

Other open comments show divided opinions (e.g., both anger and support).

# **KEY FOCUS GROUP FINDINGS**

Key findings from the focus groups:

**Policy.** Participants felt the city's elected officials lacked a clear vision.

**Communications.** Participants reported concerns about lack of transparency at the city level and trust issues for what was and what will be planned.

**Cost.** The participants expect a tax increase, but want the money to be well spent.

**Financial.** The participants worried that tax increases might impact others in the community, although they were not concerned for themselves.

**Emergency command center.** Participants were unsure whether an emergency command center is necessary. They expressed confusion about what an emergency command center would entail and questioned whether it was redundant with the facilities at Fire Station 13 on Highway 101.

#### **RESEARCH TEAM**

The Manzanita Listens research team consisted of a group of volunteers with professional research experience from Manzanita and the surrounding area, including Dr. Mary Marken, Dr. Tom Cocklin, and Jenny Greenleaf. Dr. Patricia Johnson, who does not live in the city, joined the team after the initial survey to provide focus group development, facilitation, and analysis.



# **SURVEY METHODS AND RESULTS**

This section of the report presents details about the survey, including survey methods and detailed results and analysis.

The survey asked broad questions and provided information used to to develop the discussion questions for the focus groups. City residents, Manzanita property owners, Manzanita business owners, and others who live nearby and who interact with city services were invited to share their opinions.

Survey questions focused on three areas: use of city services, building aspects, and potential methods of financing. We collected demographic information to analyze responses across different types of resident and non-resident survey participants.

The survey collected both quantitative (numerical) and qualitative (open comments) information. Responses to all open comment questions were optional.

#### **RESEARCH GOALS AND OBJECTIVES**

The research team developed the research goals and objectives in coordination with the Manzanita Listens committee, which included Manzanita City Councilors Linda Kozlowski and Steve Nuttall, as well as project manager Carter MacNichol, who owns a second home in Manzanita. Councilor Jerry Spegman later joined the committee as Councilor Nuttall transitioned to working on other city programs.

The goal for the Manzanita Listens survey was to help the city assess Manzanita public needs and desires for a new city hall given the following constraints:

- This is new construction, not a renovation of any existing structures previously considered by the council.
- City Plaza (formerly Underhill Plaza) has been chosen to be the site of the city hall.
- The project funding may include new taxes or other financing options.

#### **SPECIFIC OBJECTIVES**

The team identified the following specific objectives:

- To understand who uses Manzanita city services (demographics).
- To understand how users of different services are contacting the city for services.

- To ask respondents to rate and rank Importance of factors to be considered when planning the new building.
- To assess funding options viability.
- To allow for open comment.

#### **SURVEY PILOT TEST**

The research team loaded the survey questions into SurveyMonkey, an online survey tool, and invited one dozen local people to complete the survey as a pilot. As a result of the feedback received from pilot study participants, the research team simplified the survey and dropped several questions deemed intrusive or backward-looking.

#### PARTICIPANT RECRUITMENT

The city used a variety of methods to solicit survey respondents who were city residents, Manzanita property owners, Manzanita business owners, and others who live nearby and interact with city services. The city posted notifications on the city's website and Facebook page, on the BBQ (a local message and announcements online service), and in a locally focused Facebook group. Additionally, to ensure reach to second homeowners and business owners, the city sent a postcard with instructions about how to access the survey to any entity that had an account with the Manzanita water system.

# **METHOD**


The revised survey was loaded into and deployed using Survey Monkey. The survey was available online from November 20, 2020, to December 15, 2020. Participants could access the survey from a variety of devices, including computers, tablets, and smart phones.

#### PARTICIPANT INFORMATION

The survey received just over 500 responses; of those, 445 were complete. The team analyzed only the completed surveys for the final report. No other criteria were used to determine inclusion or exclusion for the analysis.

#### **DEMOGRAPHICS**

The survey respondents included 190 local Manzanita voters, 152 property owners who do not vote in Manzanita, 71 local area residents, 15 Manzanita business owners or local contractors, and 17 persons who described their status as *other*. The research team limited its analysis to the categories of 192 local voting residents and 152 property owners.



#### INTERACTIONS WITH CITY SERVICES

The survey asked respondents about their interactions with several types of city services over the past two years. For each service, respondents specified whether they interacted with the city for the service by phone, online, in person, or by postal mail, or if they did not interact with the service at all. Because respondents could choose more than one option, the totals do not equal 100 percent.

Note. In-person visits likely dropped in 2020 due to the COVID-19 pandemic.

The survey asked respondents about the following city services:

**General information**, which includes answers to questions about Manzanita and local services. Examples include calling the city or visiting its website to learn how to start garbage service, to find out about current mask requirements, or to seek out other general information.

**Public safety**, which includes interacting with Manzanita law enforcement and emergency response.

**Public works**, which includes contacts about roads, parks, and storm drainage.

Water service, which includes billing, account management, problem reporting.

**Public information**, which includes requests for official city information, such as public records requests or ad hoc inquiries.

**Building and planning**, which includes plan reviews, permits, inspections, and compliance reporting.

**Municipal court**, which includes attending court sessions as a participant or spectator, citations, and paying fines.

Short-term rentals, which includes. licensing, inspections, and complaints.


**Business licenses**, which includes licensing and fee payments.

**Visitors Center**, which includes contacts with the center. Examples include to get or receive information, to post information (such as flyers about events), to rent beach wheelchairs, or to participate in Visitors Center events, such as beach trash pickup.

**Meetings**, which includes City Council, Planning Commission, or other community meetings or workshops held by the city.

**Manzanita local residents** include anyone who lives in Manzanita and votes there, regardless of whether or not they own property. The following graph shows how Manzanita residents indicated they interacted with city services in the past two years.


- Manzanita residents use all forms of communication to interact with city services.
- Fewer residents interacted with the city regarding short-term rentals, business licenses, and municipal court.



#### Non-resident Manzanita property owners include:

- Homeowners who do not vote in Manzanita, such as second homeowners.
- Owners of short-term rental properties in Manzanita.
- Owners of business and commercial buildings in Manzanita.
- Those who own property in Manzanita, but do not vote in the city.


The following graph shows how non-resident Manzanita property owners said they interacted with city services over the past two years.



- Non-resident property owners often contacted the city for general information, but were less likely to interact with most other city services, except for the water department.
- Non-resident property owners were more likely to visit the Visitors Center.

# COMPARISON OF CITY SERVICE USE BY RESIDENTS AND NON-RESIDENT PROPERTY OWNERS

Local residents are much more likely to visit city offices in person to access services.



#### **ADDITIONAL SERVICES**

Survey participants were asked what, if any, additional services they would use if they were available at a Manzanita public services building (city hall). Survey respondents offered many suggestions, though analysis revealed some common themes. The following sections present highlights. All responses to this open-ended question are appended to this report.

Participants indicated that they wanted:

- Large and small meeting rooms
- Electric vehicle charging
- Disaster preparedness and gathering point



- Info about indigenous people/historical connection
- Tsunami warning alarm
- Emergency phone

- Develop a chamber of commerce
- Use adjacent land for affordable housing
- Public showers
- Services for low-income individuals
- Basketball court and outdoor event space
- Use parking lot for many things, including overflow
- Electric vehicle charging
- Farmer's market
- Venue for music
- Community garden
- Arts sharing opportunities
- Accessible
- Create a city revenue stream by renting or leasing extra space
- Respects Pacific Northwest culture
- Restrooms

#### **DIVISIONS: AREAS OF DISAGREEMENT**

The research team's analysis of the comments received for this question showed areas of disagreement among respondents. Key points included:

- Low cost vs. uses and durability
- Look (aesthetics) is important vs. look is not important
- Emergency preparedness
  - Taking care of neighbors and visitors vs. everyone preparing for themselves
  - Preparedness is not important because Fire Station 13 covers preparedness
- Consolidate city departments vs. do not co-locate public safety with other city services
- Use green/alternative energy sources vs. use conventional energy sources
- Remodel the old building at City Plaza vs. do not remodel
- Meeting rooms are important vs. meeting rooms are not important



# **BUILDING ASPECTS**


The survey asked respondents to evaluate several aspects of a potential building. While respondents said that they thought each of the aspects was important, when asked to rank the aspects, cost emerged as a clear choice as the most important.


#### **IMPORTANCE OF BUILDING ASPECTS**

The following graphs illustrate the importance Manzanita residents and Manzanita property owners (combined) assigned to each building aspect they were asked about.


Cost of constructing and maintaining the building.

Building sustainability, such as energy efficiency, alternative/renewable energy sources, and electric vehicle chargers.







Scalability. The building can be added to at a later time.




Aesthetics/architecture. What the building looks like.




Emergency services. How important is it that the building be designed to be used as an emergency command center when needed?



Useful life of the building. How long it will last.




Large community meeting/event space that accommodates up to 150 people. For comparison, the Pine Grove Community House holds 99 people.




# COMPARING BUILDING ASPECT IMPORTANCE: LOCAL VOTERS VS. NON-RESIDENT PROPERTY OWNERS

**Local voters** rated cost as the most important aspect to consider for the new city hall building. They also rated useful life, emergency services, sustainability, and scalability as important aspects. Local voters considered aesthetics and meeting space least important.



**Non-resident property owners** placed most importance on emergency services, followed by useful life, sustainability and cost. The non-resident property owners rated meeting space as least important. Non-resident property owners were more concerned with aesthetics than local voters.



#### **ADDITIONAL ASPECTS**

The survey gave respondents an opportunity to list additional building aspects that they felt the city should consider. The results indicated that the participants wanted to have the city focus on cost, emergency services, sustainability, and an appropriately sized building for the town. They wanted the building to be humble, durable, and accessible.

Some respondents expressed that the building should be sunny, safe for employees, and multifunctional. There were strong feelings expressed both for and against including emergency preparedness features.

Some participants expressed anger with the mayor, the Manzanita City Council, and city government in general.

The responses showed the effects of the COVID-19 pandemic on building plans, as some participants questioned whether staff could work remotely.


Other comments noted that project should use local contractors to design and build the city hall. They wanted the building to feature local art and history displays, to have adequate parking, to make good use of the outdoor space, to have public restrooms, and to be designed for future growth. All responses to this open-comment question are appended to this report.



#### ASPECT RANKING

Survey respondents were asked to rank building aspects from most important to least important. The following graph shows how Manzanita residents ranked the aspects vs. how non-resident property owners ranked the aspects. Cost emerged as the most important aspect for both groups, while emergency services ranked second.

Non-residents ranked aesthetics and emergency services higher and are not as concerned about cost. Residents were more concerned with cost, useful life, and scalability.



#### **RANKING COMMENTS**


The survey asked respondents to comment on why they ranked the aspects the way they did. Many of the responses echoed previous open comments. All responses to this open-ended question are appended to this report.

#### **FINANCING METHODS**

The survey asked only local voters questions about financing methods. The city planned to discuss financing more completely with non-resident property owners during the focus groups and public meeting steps in the Manzanita Listens research process.

The survey asked respondents about four different financing methods and whether they would or would not support each method.

**Note.** The survey team received feedback that the financing options were not well understood by many survey respondents. We further learned that the item labeled "short-term rental nightly surcharge" is actually a licensing fee, such as was recently instituted for Tillamook County. The research team used this feedback to better develop the focus group questions.



# **ADDITIONAL COMMENTS**

The survey offered respondents the opportunity to make additional comments about the city hall project if they desired to provide them. All responses to this open-ended question are appended to this report.

- Participants expressed thanks to the city for conducting the survey, and they
  were grateful for the ability to voice their opinion.
- Some people reiterated their desire for a simple, durable, functional, and lowcost building.
- People offered a range of opinions about funding the building.
- Respondents wanted the building to be safe and comfortable inside for city employees.
- Respondents largely agreed that the building would serve some preparedness activities.
- Other responses indicated that some of the participants wanted to hold down costs using a phased construction approach.
- Some second homeowners said that they felt that their opinions did not matter.
- Respondents expressed many concerns about cost and the desire for the city to explore grants and other funding sources.
- Some respondents anger at the idea of paying for visitor or second homeowner disaster preparedness.

# **FOCUS GROUP METHODS AND RESULTS**

The research team conducted a series of three focus groups in February 2021 to further investigate issues related to the planning and construction of Manzanita's city hall.

A facilitator and note taker conducted the 90-minute sessions and major themes emerged. These themes represent the results from this study and will be used, along with the survey results, to drive objectives for the next step of the Manzanita Listens project, public meetings.

#### **OBJECTIVE**

The research objective for the focus groups was to collect broad and rich data about factors related to a new Manzanita city hall. Specifically, we investigated issues that arose in the survey, including cost and financing results, key building aspects, and citizen concerns around the project, both historically and over the coming year.

#### **PILOT FOCUS GROUP**

The research team held a pilot focus group to assess the appropriateness of the questions that had been developed. The team recruited five persons who had not volunteered to be part of the focus groups. A pilot focus group was held over the Zoom video-conferencing platform.

#### RECRUITMENT

Focus group participants were recruited using the pool of names collected from the Phase 1 survey respondents. Survey respondents were invited to volunteer for focus groups and provide contact information.

Two pools of potential participants were created using the names of those who volunteered during the survey. One pool included 59 local voters, and the other included 50 non-resident property owners. A random number generator was used to determine the order in which the volunteers were contacted.

We conducted two groups with Manzanita voters (renters and owners), and one group with non-resident property owner participants. Participant identities remained anonymous to all but the research team. Potential respondents were contacted by email or telephone to assess their continued willingness to participate and were asked to sign a

release and informed consent form. Participants had no prior knowledge of their group assignment or who was included in their group. There were 12 male participants and 5 female participants.

- Group 1 included five Manzanita voters.
- Group 2 included six Manzanita voters.
- Group 3 included six non-resident Manzanita property owners.

#### **METHOD**

Due to COVID-19 constraints, focus groups were conducted using the Zoom video-conferencing platform. One facilitator per group session used a facilitator guide to drive conversations about topics. A note taker was also present. The focus group sessions were closed to all but the participants, the facilitator, and note taker. The sessions were video-and audio-recorded to enable analysis.

To reduce possible bias, facilitation was conducted by an independent PhD researcher who did not have a relationship with the city and who was not involved in Phase 1 survey planning, execution, or analysis. Standard focus group facilitation practices were used to ensure that all participants had a voice during each session.

Participants were not paid for taking part in the roughly 90-minute sessions.

# **FOCUS GROUP QUESTIONS**

Participants answered five questions that were based on the results of the survey conducted in November and December 2020. The five questions covered issues related to the construction of a new city hall building:

- Cost
- Financing
- Emergency communication center at city hall
- Feelings about the controversy associated with the previous project/bond
- Additional comments for the City Council to consider

Participant reactions to each question are summarized here, and suggestions for the city are included where appropriate.

#### **QUESTION 1: COST**

Most participants were not overly concerned with the impact of a tax increase to them, personally. Those who did mention the inevitability of a tax increase wanted to be sure their money would be well spent and that risk (i.e., high debt loan risk) to the community be reduced. While some commented that they wanted the city to be sure to build a facility that was going to meet the primary needs for Manzanita right now, more of the participants mentioned the need to not be shortsighted.

The participants wanted the city to build the *right-sized* building and not build something that was too big or too extravagant. A few suggested a phased approach might be best; however, others did not feel a phased or modular approach would be suitable because the costs to add on may be prohibitive in the future. Key terms included quality, durability, usability, and functionality.

"My concern, I guess my bias, about the question of cost is making sure that you're not penny wise and pound foolish, as my grandmother would say."

A suggestion for the city would be to address and add these terms to their vocabulary when discussing the project to illustrate that the city listened. Some participants said they conducted research on their own and they described how the \$600 square foot model put forth in the bond was outside the normal charge per foot for a new city hall. The city should clearly communicate why or how their square footage plans are, or are not, outside the norm.

Many commented that the city should first concentrate on figuring out what is needed or necessary in the building. Many also suggested there is no clear strategic vision for what type of building they want. "What are we trying to accomplish?" asked one participant. There were many comments that included concerns that the city would "cheap out" and not spend money wisely as the building is designed and developed.

Most wanted the building to be aesthetically pleasing, reflective of the area, and sustainable for many years. Comments related to sustainability centered on a long useful life built with quality and local materials. They also wanted it to be easy to maintain, and they wanted it to be built using good building practices.

A suggestion for the city would be to clearly describe their strategy as they work to design and build the new city hall. Efforts should be made to address the concerns and use the same words: effective, durable, functional, usable, and sustainable. The City Council should work to clearly describe their decisions as based on the research results.

One person described how the building should be LEED certified, and some seemed to agree. More of the respondents described how they wanted the building to be "green." Those who said the building should be green described using solar energy and other renewable sources.

Most mentioned that the building should be safe for employees and visitors, meet seismic codes, have a design that meets the needs of the employees, and use alternative energy sources, if possible. The participants also described how the city should use local architects, craftspeople, and local materials. A few participants felt that the city should consider being innovative with the need for space, suggesting that employees working remotely might be a cost savings.

A suggestion would be for the city to clearly describe their efforts to work with local builders and craftsmen, and to explain reasons for not seeking local workers, if they cannot do so. The city should also research whether LEED certification is an acceptable approach, and the recommendations for moving forward should include information about why or why not a LEED approach was appropriate.

#### **QUESTION 2: FINANCING**

Another topic in the survey asked about how to finance this project. Most respondents indicated that they favored a short-term rental nightly surcharge as the top method to pay for the building, followed by a bond measure or local tax, and then by using development impact charges.

Most participants favored using a combination of bonds and loans, and they favored selling existing city properties to fund the project. A few suggested that a bond alone would be the best approach. Several participants suggested that interest rates were currently attractively low, which would keep the costs of a loan down. While using some sort of short-term rental fee was compelling to some, most others did not feel this was an approach that should or could be used to be equitable and because they were worried the money could be co-opted if the city needed it. Others worried it might be a "slippery slope" to add to rental fees for city purposes. Many mentioned that any financing scheme should be as equitable as possible, and the city should take into account other possible sources of funding, such as grants and fundraising efforts. Efforts should be made to ensure equitability and communicating about equity will be key.

A few participants felt that a phased approach to meet the immediate needs of the city would make the financing less costly; however, others felt that having a clearer understanding of what the building would be (i.e., the strategic vision) would help define the funding needs. One person suggested that the city could try to be more innovative

with zoning regulations and increase taxes on new construction to help fund the new city hall. They suggested that larger home designs that do not fit with the character of the village should pay a premium that could go to fund the new city hall. Another suggested that the five lots the city owns on the city Plaza site could be sold to help offset the costs for the new city hall building.

There were several comments regarding the equity of the financing given that there are those who are able to vote for a bond and those who are not. Many thought that other voices needed to be heard as decisions are discussed and made by the city. Some were very engaged with the process and sought out

information. Others wanted the information sent to them in as many forms as possible; they felt the city should reach out to them rather than simply putting the information on the city's website or on FaceBook.

# **QUESTION 3: EMERGENCY COMMAND CENTER**

The second-highest ranked aspect was emergency services—that the building be designed to be used as an emergency command center

After sharing details with each group about what an emergency command center was, and was not, participants generally reacted negatively about having such a center as a part of the new city hall building. Most commented that they felt this would be duplicative of the resources at Fire Station 13, redundant, or not needed for Manzanita. One person asked why we needed one when Nehalem and Wheeler did not. There were several comments about the cost of Fire Station 13 and that fire station should be used rather than having another emergency center. There were those who felt that an emergency command center was a good idea if it was a "spoke" on the wheel of a broader emergency response system.

Most participants did not feel this should be a priority when determining what was needed for a new city hall. A few participants did feel it would be useful to have an emergency command center at or near the new city hall. There were some comments about having the capacity for using the space around the new city hall as a gathering place after a major disaster.

If the city believes an emergency command center is an important factor, they should communicate to voters exactly what an emergency command center is, how much room would be necessary, and why it is necessary apart from Fire Station 13. They should also clearly communicate how the city would be able to continue to handle business within the building if it did become an emergency command center (although it may not be very likely that any business would be going on at the same time). This was a question from a participant, and it should be described as a small part of future messaging.

#### **QUESTION 4: CONTROVERSY**

Many participants related that they experienced feelings of anger or resentment at the manner in which they perceived they were treated by the City Council. Several mentioned that it appeared to them that if the Council did not like suggestions or comments they would ignore them, especially if the ideas presented ran counter to the decisions it appeared the City Council had already made. A few felt that decisions were made prior to public meetings, and the public meetings were simply 'for show.' There were many comments about poor communication and confusing messages about what the project was really going to be. A new city hall? An emergency center? Both? No public input into the purchase of the property left some feeling a lack of trust in the entire process. How the remodel ideas were 'taken off the table' also made some feel as if their opinions had not been adequately addressed. Many said they felt left out of the conversation.

Many mentioned that communication efforts fell short in several aspects, especially reaching out to the entire community (i.e., residents and non-resident). The communication processes used were not effective in creating a way for all who would be impacted to feel as if their voices mattered. One participant stated, "The process that went into how the whole thing came about was pretty ugly. I think that a lot of good ideas were lost by poor process." Another suggested, "Not being a voter in the area, I think I would propose to the city leadership that they need to include information that gets disseminated not

just to all voters, but to all property owners in the area. I think that's what generates a lot of the ire between groups."

A few participants mentioned that they heard anger from others related to the potential property tax increase and how unhappy that made some residents. They felt that the anger expressed by some had more to do with a lack of clarity about what the city proposed, and people felt the City Council's motives were suspect because of the lack of clarity.

Participants offered specific ideas and suggestions to improve communication and engagement going forward. One participant's suggestion was typical of many comments:

"I think the lesson for the City Council, and hopefully from this work you're doing, is that we're able to share that thought with them, is maybe we need to look at how we communicate. I think it comes to two things: Get away from explaining how, to explaining what, and explaining why [emphasis on how, what, and why] and doing that in a way that is simple and easy for people to digest. When you start running into the how, this is where we get into problems because people don't understand what's the vision, what's the strategy, what are the goals that you're trying to go achieve, and then 'Now I understand what you're going for, now I can have a better conversation around how we get there.' But I think it becomes incumbent upon us that we get folks to understand that and then we pump that information into the community in a way that is digestible. Looking at 160-page report or the 10 options, I think the average citizen, I think their head kind of explodes with it."

A few commented on how the process of democracy is messy at times, and that it is hard to ensure the best outcome, especially if some do not have good intent. Virtually every participant thanked the city for carrying out the survey, focus groups, and listening sessions.

There were a few comments about how to use the space at City Plaza. Suggestions included affordable housing, using technology to right-size the building, and having green spaces available around the building.

#### **QUESTION 5: OTHER THOUGHTS**

The responses were many and varied. They are summarized into five general categories: communication, use of space, design elements, renewable energy, and support for employees. These responses also largely reiterated what was said earlier.

**Communication.** Communication emerged as a major theme across focus groups. Some did not believe the city worked hard enough to provide information about the project to the voters and non-voters; however, some admitted that they did not seek out information.

Participants suggested the city create a clear vision to help citizens understand what the City Council wants and craft responsive messages that reach beyond voters.

Communicate the strategy with a crisper and succinct vision. One participant suggested, "What is it they want to be held accountable to and march to that."

Additionally, the participants wanted the City Council to be innovative in reaching out to the community. They suggested having a webpage specific to this project where people can review materials, make comments, and get answers to questions. Include everyone. Use emails or postcards to reach out to all who are impacted, not just local voters. One person suggested that the City Council minutes be sent via snail mail to residents because there are those who are not computer literate. "We are all paying taxes, we all should have a say on this," said one participant,

which illustrated the participants' call for equity. The participants want the city to create safe environments where all can participate without feeling intimidated. The participants wanted to feel like they have been heard.

**Use of space**. Several participants encouraged the City Council to include the area around the new city hall building as a beautiful public area—a park, a garden, perhaps community vegetable gardens, or other types of natural areas. As one participant said, they want "A place we would all want to go to."

**Design elements**. Be respectful and inclusive of local culture and the natural environment. In addition, the participants want the city to use local art and perhaps incorporate materials from the old building in the new building to pay tribute to the history.

**Renewable energy**. Several participants encouraged the use of green, renewable energy sources. Achieving LEED certification was also suggested by one participant.

**Support for employees.** The participants wanted the City Council to know that they support the city employees, and they felt the employees deserved a healthy and safe place to work.
