

**CITY OF MANZANITA
PLANNING COMMISSION MEETING MINUTES
SEPTEMBER 20, 2021**

I. CALL MEETING TO ORDER: Chair Karen Reddick-Yurka called the meeting to order at 4:03 p.m.

II. ROLL: Members present were: Karen Reddick-Yurka, Burt Went, Phil Mannan, John Nanson, Lee Hiltenbrand and Jenna Edginton. Due to issues logging into this Zoom meeting, Steve Bloom was unable to join the meeting until 4:33 p.m. There was a quorum. Staff present: City Manager Leila Aman, City Planning Consultant Walt Wendoloski, Public Works Director Dan Weitzel, Building Official Scott Gebhart, and License and Ordinance Specialist Judy Wilson.

III. AUDIENCE: There were 13 persons in the audience.

IV. APPROVAL OF MINUTES: August 16, 2021

Commissioner Mannan noted that Jesse Cereghino's name was misspelled at the beginning of the Applicant's Presentation at the bottom of page 1.

A motion was made by Nanson, seconded by Went to approve the minutes of the August 16, 2021 Planning Commission meeting as corrected. Motion passed unanimously.

V. AUDIENCE PARTICIPATION: An audience member identified as Frank stated that his wife wanted to make a comment but was having trouble logging into this Zoom meeting. Chair Reddick-Yurka stated that they would come back to her for her comments at the end of the meeting.

ANNOUNCEMENT OF PUBLIC HEARING PROCEDURES: Chair Reddick-Yurka described the process for the public hearing.

VI. PUBLIC HEARING: FINAL PLAT FOR HIGHLANDS SUBDIVION PHASES 3 & 4 WITHIN THE SPECIAL RESIDENTIAL/RECREATIONAL ZONE; LOCATION: CLASSIC STREET AND NECARNEY CITY ROAD; APPLICANT: ENCORE INVESTMENTS, LLC (JIM PENTZ AND RICK HINKES)

A. OPEN PUBLIC HEARING - Chair Reddick-Yurka noted the application being considered and opened the public hearing at 4:07 p.m.

B. CONFLICT OF INTEREST, BIAS OR EX PARTE CONTACTS INCLUDING SITE VISITS - Edginton, Went, Hiltenbrand, Nanson, Mannan and Reddick-Yurka stated that they had no conflict of interest, bias or ex parte contact, and noted when they had last visited the site.

- D. APPLICANTS' PRESENTATION** – Rick Hinkes gave an overview of the project and stated that Phases 3 and 4 have been combined into only Phase 3. Jim Pentz gave an update on the progress of the completion of infrastructure and paving stating that they should have everything completed on time but will bond any improvements that they are not able to.
- E. STAFF REPORT** - City Planner Wendoloski explained that this was a combined review as one plat for both phases and stated his recommendation of approval with either the applicant completing the improvements or bonding to complete them before the Chair signs the final plat.
- F. QUESTIONS FROM THE COMMISSIONERS** – Commissioners, staff, and the applicants discussed the paved turnaround area referenced in item 3(1) on page 3 of the staff report; the re-platting and Tract E referenced in Item D on page 2; and that all four sheets of the submission including the infrastructure, streets and lots are being considered for approval and will be recorded. Wendoloski will correct the date stated in item F on page 1 from August 16, 2021, to May 17, 2021.

She informed the Commission that there will be a workshop early next year for them provide feedback.

Wendoloski noted and commented on the Manzanita Deli’s request for an extension of time for their project.

A motion was made by Nanson, seconded by Went to adjourn the meeting.
