Officer Shifts

- 1 dayshift officer and 1 nightshift officer
- Shift hours change depending on day of week and officer's time off
 - Example: An officer may work until 10:00pm, go home (on call) and come back and work 2:00am-05:00am. We try to be random, especially when we have thefts start occurring at night.
- Time between those shifts are covered by an officer being on call which averages approximately 2400 hours per year at only \$3/hr compensation



POLICE CONTRACTS

Contracts

- 1. City of Wheeler
 - 15 hours per month
 - 30 minutes per day
- 2. City of Nehalem
 - 20 hours per month
 - 40 minutes per day
- 3. Oregon Parks and Recreation
 - Nehalem Bay State Park
 - Oswald West State Park
 - Approximately 250 hours per year
 - June-August = 7 hours per week
 - September-May = 4 hours per week

Benefits of Contracts

- Gives officers the ability to track known suspects who don't live in our City
- Able to watch known criminals and houses
- Know who associates with who
- Know who is currently in the area that maybe going to commit crimes(mainly thefts)
- Ability of the officers to leave the City of Manzanita helps with retention/burnout and gives the ability to more effectively do our jobs.
 - Traffic stops
 - Traffic safety
 - o Identifying suspects
 - Looking for stolen items
 - Warrants

Impacts of Covid

- Morale
 - Officers had more negative contacts during this time with people
 - At a time of growing anti police feelings.
 - Despite the Stay At Home orders and restricted parking by City/County/State Parks there was an extreme amount of day travelers.
- Fingerprinting stopped
- DMV related driving infractions not enforceable
- TFCC not responding to as many mental health calls
- Tillamook County Jail is only taking select few inmates
 - Higher level felonies
 - Not taking
 - Theft suspects
 - Resisting arrest
 - DUII
 - Warrants
 - Disorderly conduct
