COUNCIL ORDINANCE No.

AN ORDINANCE OF THE CITY OF MANZANITA, OREGON, TO INCREASE LIVABILITY AND PROTECT THE NATURAL ENVIRONMENT FROM THE IMPACT OF OUTDOOR LIGHTING BY MINIMIZING LIGHT POLLUTION, GLARE, AND LIGHT TRESPASS AT NIGHT.

WHEREAS, reducing light pollution at night preserves and protects the natural environment; and

WHEREAS, limiting light pollution will enhance the quality of life within the City of Manzanita for humans and wildlife; and

WHEREAS, the City of Manzanita can regulate and enforce limitations to outdoor lighting to achieve these goals; and

WHEREAS, the City Council has determined that it is in the public's best interest to implement regulations to protect and preserve the environment and enhance livability in the city.

Now, Therefore, the City of Manzanita does ordain as follows:

Section 1. **Definitions**

The following words and phrases, as used herein, shall have the following meanings:

- A. <u>Fully Shielded-</u> A light fixture that has a solid barrier at the top of the fixture in which the lamp (bulb) is located. The fixture is angled so the lamp is not visible below the barrier at a horizontal plane.
- B. <u>Kelvin</u>- Used in lighting to measure the color temperature of a particular light bulb.
- C. <u>Landscape Lighting</u>- Lighting designed to illuminate walkways, trees, shrubs, ponds and other landscape features.
- D. <u>Light Trespass</u>- The unintended or excessive illumination of adjacent properties, public spaces, or sensitive environments due to poorly designed, directed, or uncontrolled outdoor lighting.
- E. Owner- An owner of property or the authorized agent of an owner.
- F. <u>Patio Lighting</u>- Temporary lighting to include string lights, lights that may plug in, and solar powered lights. Lights shall have a measurement of 3,000 Kelvins or less.
- G. <u>Seasonal Lighting</u>- Temporary lighting installed and operated in connection with holidays or traditions.

Section 2. Prohibited Uses of Lighting

A. All outdoor light fixtures shall be fully shielded, and the bulb pointed in a downward direction so that light does not radiate from the sides or top of the fixture.

- B. Lights shall be turned off when not in use and shall not be left on for more than 12 consecutive hours. Porch lights may be fitted with motion detectors.
- C. Patio lighting shall be prohibited between the hours of 12:00am-6:00am.
- D. Landscape lights shall be prohibited from illuminating in an upwards direction beyond the property boundaries.
- E. Security (flood) lights shall be on motion detectors and must not shine on adjacent houses.

Section 3. Exemptions

- A. Seasonal lighting installed and operated in connection with holidays.
- B. The American Flag may be displayed at all times if it's illuminated during darkness.

Section 4. Violation - Penalty

Any person who is convicted of a violation of any provision of this ordinance shall be subject to a civil fine of not more than \$250 for each offense.
