2. Of the issues facing Manzanita, what is the most compelling to you personally, and how would you address it?

The word "livability" seems to cover many of the issues that Council will be confronted with as we move forward. Livability encompasses issues that have to do with keeping a neighborhood feel to the town. I was drawn to Manzanita by its quaint feel and the comfort that I feel walking through the streets. I love to see families here on vacation. That means there needs to be a balance with short term rentals that permits them, encourages them, but doesn't make this a place that I don't want to live in.

I intend to live in Manzanita until my health won't permit it. That means living here needs to be affordable. Increases in taxes, new bond issues or other fees are inevitable, but we need to keep out eye on how they affect local residents' ability to continue to live in the city.

I love our local shops and restaurants, but I can't enjoy them if they can't keep their doors open because they can't find workers to work in them. Workforce housing is required by law now so seeing that expansion occur while maintaining the feel that we all love will be a challenge.

3. What is your understanding of the division of responsibility between the city council and the manager/staff?

The division of responsibility is addressed in the City's budget at pages 15 & 16. See attached. That articulation of the division is well stated. The only part that I see missing is some statement about accountability. The Council is accountable to the electorate. The City Manager is accountable to Council. Staff is accountable to the City Manager. At each level, whether via elections or employee performance reviews there must be a check in place to grade whether the person or body being reviewed is following the mandate given.

4. Is there anything else you would like to share with the selection committee about your experience and interest in the position?

I would be honored to be selected. I think that my experience on the Green River College Board will be the most helpful to me as a council member. That position required me to balance many different factions that all had a shared objective (student success) but too many times different visions about how to accomplish it. The work was many facetted. I worked with the administration and had to understand concerns of faculty. I had to communicate with students to understand their challenges. I had to make myself answerable to local employers and community groups. This is a job that I think that I can do.
