Proof of payment of your \$850 license renewal fee (This fee should be paid via this link on the City of Manzanita website: <u>https://secure.xpressbillpay.com/portal/payment_forms/?id=MzE1NTQ%3D</u>. If you pay with an e-check instead of a credit card, that company does not assess a processing fee. Make sure you choose "STR Annual License Renewal Fee" from the dropdown menu so that you pay the correct amount.)

This license renewal is for the term of August 1, 2023 through July 31, 2024. Upon receipt of payment and a complete renewal packet, a new annual Short-term Rental License/Certificate of Authority will be issued. It will be issued to the Local Agent for posting in your rental as required.
