1. RE-OPENED RECORD PERIOD (March 21, 2025 – March 27, 2025)

As part of its de novo review, the City Council will consider the existing record, including all timely submissions to the Planning Commission regarding this matter. From March 21 to March 27, the City Council is reopening the record for new submissions. Participants may submit new evidence, testimony, and argument, including any responses to information or materials in the existing record during this time. <u>New evidence, testimony, and argument, including any responses to the existing record must be submitted by **5:00 p.m. on March 27, 2025.** New submissions to the record received during that time will be posted on the City's website and available for review on March 28, 2025.</u>

2. RESPONSE PERIOD (March 28, 2025 – April 3, 2025)

All parties will have an opportunity to respond to the materials received during the Re-Opened Record Period between March 21, 2025 and March 27, 2025. Materials submitted at any time after March 27, must be in response to the materials submitted during the Re-Opened Record Period. <u>Responses must be submitted by 5:00 p.m. on April 3, 2025.</u> After April 3, 2025, 5:00 p.m. no new written evidence, argument, or testimony will be accepted except that the applicant will have a final opportunity to submit written argument (but no new evidence).

3. APPLICANT'S RESPONSE PERIOD (April 4, 2025 – April 10, 2025)

The applicant only will have an opportunity to submit final written argument (but no new evidence) in support of the application by **5:00 p.m. on April 10, 2025**.

4. DE NOVO HEARING DATE (April 14, 2025, 4:00 p.m. via Zoom)

The City Council will hold a public hearing on the application on **April 14**, **2025 at 4:00 p.m.**, at which it will receive public comments and argument,
