

IMPORTANT NOTICE THAT MAY AFFECT YOUR PROPERTY THIS IS TO NOTIFY YOU THAT THE CITY OF MANZANITA HAS PROPOSED A LAND USE REGULATION THAT MAY AFFECT THE PERMISSIBLE USES OF YOUR PROPERTY AND OTHER PROPERTIES.

On <u>June 9, 2025 at 4:00 pm</u>, the Manzanita Planning Commission will hold its first public hearing, located virtually on Zoom (https://us02web.zoom.us/j/81642434407?pwd=RvS5xN0N3SlcxG21wmE4YEBC6wCN24.1 Meeting ID: 816 4243 4407 Passcode: 080410) regarding the following: Manzanita Ordinance Amendments to 95-4: Zoning Ordinance and 95-5: Subdivision and Land Partition.

The City of Manzanita has determined that adoption of this proposed text amendment may affect the permissible uses of your property, and other properties in the affected zone(s), and may change the value of your property. Copies of the proposed text amendment will be available for inspection on the City's website by download and in person at the temporary City Hall site located at 167 S. 5th Street at least seven (7) days prior to the initial public hearing at no cost. Hard copies will be available for purchase at \$0.25 per page.

This public hearing will be the first of at least two hearings on the proposed changes, one of which will be conducted before the Planning Commission and another which will be conducted by the City Council. The initial public hearing will include an overview of proposed updates, timelines for review and adoption, and opportunities for public involvement.

THESE ORDINANCES MAY OR MAY NOT LIMIT THE USE OF YOUR LAND

State law requires the City to mail notices to property owners with specific language used on this side of the notice. All property owners with any amount of land in residentially zoned land including R-2, R-3, R-4, RMD, and SR-R are receiving this notice, and the City has no way to verify whether, how or when proposed land use regulations or zone changes will affect the value of individual properties. Your receipt of this notice does not necessarily mean that any proposed land use regulation or zone change will limit the use of your property or impact the value of your property.

PROPOSAL: The City of Manzanita is proposing updates to the Manzanita City Ordinances

95-4 and 95-5. The proposed updates allow the city to comply with and exceed housing-related statutes and facilitate housing production, affordability, and choice. Amendments will also comply with regulations of Tillamook County's

Senate Bill 406, and thus House Bill 2001.

APPLICABLE STANDARDS: 95-5 (Land Subdivision and Partitions), 95-4 (Zoning Maps), 95-4 (Land Use

Districts), 95-4 Section 4.160 (Supplemental Standards for Middle Housing)

All interested parties are invited to attend the hearing online may testify orally, if they choose. Written testimony may be submitted by email to planning@ci.manzanita.or.us or regular mail. (Please note the City's mailing address is: PO Box 129, Manzanita, OR 97130.) Written testimony for the June 9, 2025 meeting will be accepted until 12:00pm June 9, 2025.

Any correspondence received in advance of the meeting will be forwarded to the Planning Commission.

A copy of the proposed amendment text, all submitted documents, and applicable criteria are available for inspection at no cost at least seven (7) days prior to the hearing. In addition, a staff report will be available for inspection at no cost at least seven (7) days prior to the hearing.
