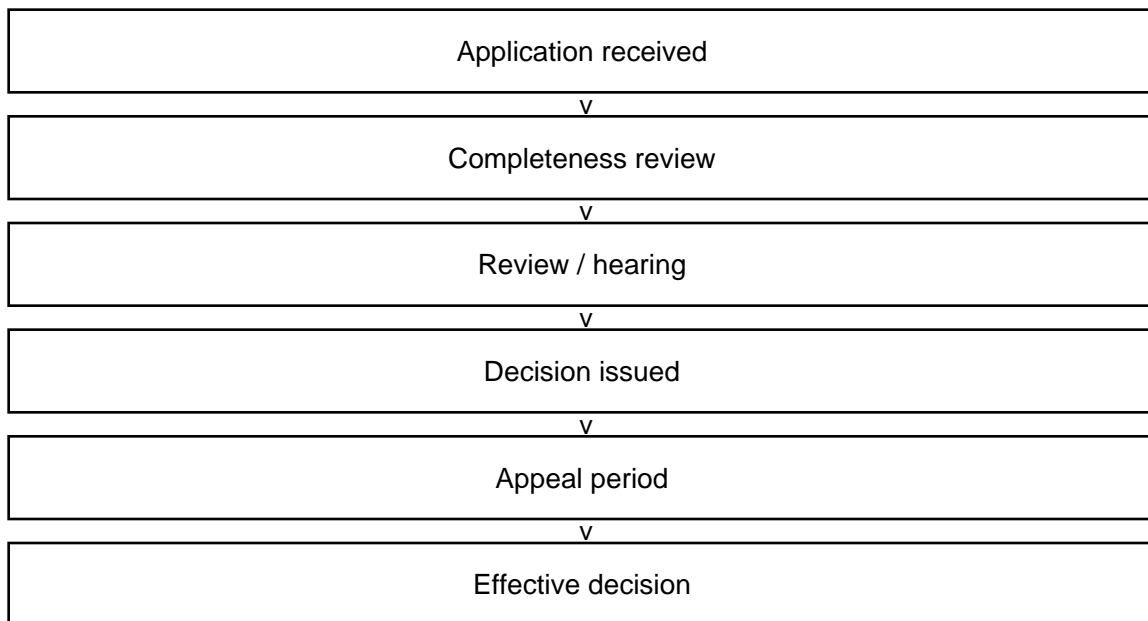
## Type 2 Review Timeline & Process

Summary from Zoning Ordinance Article 10 (Procedures).

### Timeline (summary):

- Submit application (Day 0).
- Completeness review.
- Public notice and hearing procedures apply (Sections 10.030-10.110).
- Decision and notice of decision (Sections 10.120 and 10.140).
- Appeal of Planning Commission decision to City Council within 20 calendar days (Section 10.150(B)).
- Final action within 120 days of complete application (Section 10.220).

### Ordinance citations (non-exhaustive):

- Notice of decision: Section 10.140.
- Appeals / requests for review: Section 10.150.
- Final action deadline: Section 10.220.
- Hearing procedures and rights: Sections 10.070-10.110.
